COSTS OF VULNERABILITY

The cost of preventable health and social outcomes faced by youth over a 20-year period has been put at **£4 trillion**

Excluded from school



£15,000 pa for Pupil Referral Unit, vs. £4000 pa for mainstream school

Estimated lifetime cost of permanent exclusions from school **£650 million**

Mental health problems



One in ten children and young people aged five to 16 has a clinically recognisable mental disorder

The cost to society of adult mental health problems is currently estimated at more than **£100 billion**

Unstable accommodation



80,000 under 25s become homeless each year

£1 billion spent annually on dealing with homelessness

In care or a care leaver



Estimated **£2.5 billion** was spent on looked after children's services in England in 2013/14

Asylum seeker, refugee or migrant



Many wait 'in limbo' for **5 - 8 years** for their application decisions, unable to continue into education

Estimated **120,000** irregular migrant children live in the UK

Contact with youth justice system



Costs £19 billion a year

Early intervention and prevention for 10% of the young people sentenced to prison **could save over £100 million annually**

94%

of our young clients said JfK Law's help had **made a difference to their situation**



72% said they knew nothing or not much about their rights before JfK Law's help.

Afterwards, **all of them** had some knowledge, with **74%** saying they now knew a lot about their rights

83%

said their situation was affecting them a lot before JfK Law's help.

WORKING FOR SYSTEMIC CHANGE

YOUTH JUSTICE



We responded to over **100** external youth justice enquiries



We responded to **six consultation papers** about youth justice; our ambassadors gave oral evidence on two occasions separately

We attended over 12 discussions in parliament

Shauneen Lambe acted as an **advisor to Independent Parliamentary Inquiry into Operation & Effectiveness of Youth Court**, led by Lord Carlile



We **delivered over 25 training sessions and speeches**, to organisations ranging from the Law Commission to the Faculty of Forensic Medicine to Youth Offending Teams



We acted as legal intervenors, providing expert evidence on youth justice issues, in **3 CASES IN HIGH COURT & COURT OF APPEAL**

Barristers and QCs from leading chambers provided Just for Kids Law with **Pro Bono Legal Representation** to enable legal interventions



WORKING TO ENSURE THE RIGHTS OF THE CHILD

CAMPAIGNS

Our **#stillachildat17 campaign** calls for an end to ALL legal loopholes that allow arrested 17 year olds to be treated as adults in the police station. The campaign has been extensively covered, including in *Sunday Times*, *BBC Newsnight*, *BBC Radio 1*, *BBC North-West*; and prompted a debate in the House of Lords.




Our **youth ambassadors campaign** for the rights of other **young people**, including campaigning for young migrants with university places to have the same right to student finance as everyone else

Our **'stop and search' video**, informing young people of their rights when they are stopped and searched by the police, was launched in June 2014 and **has been viewed over 900 times**
